Regular Meeting May 13, 2021 7:30 PM

May Sullivan called the virtual meeting to order with a flag salute. This meeting was duly advertised in accordance with the Open Public Meetings Law, PL 1975, Chapter 231.

Call of the Roll: Mayor Sullivan, Mr. Carrow, Mr. Miller, Mrs. Pierce, and Mr. Linton. Absent: Mr. Corwonski. Also present was Solicitor Rybeck.

Committee Reports

Public Safety Chair-Mr. Mallon reported that the police report for the month of April was distributed to Council. The Town Yard Sale will be held Saturday June 5 in conjunction with the recycling center being open. Movies in the park is scheduled for June 23 and the movie is "Dumbo." Mr. Miller agreed to extend the closing time of the recycling center an hour later due to the yard sale.

Finance Chair- Mr. Carrow advised that ordinance is on the agenda this evening that allocated monies for water projects.

Grants/Economic Development/ Communication and Information Technology Chair-Mrs. Pierce announced that we have had additional signups for the one call system. A call will be sent to residents a week before the yard sale and movies in the park.

License & Inspection/Health& Welfare – Mr. Linton reported that 12 permits were issued for the month of April for a total of \$4,084.

Recycling and Trash/ Buildings, Grounds, Roads Chair- Mr. Miller reported that the flushing program will be completed by Monday or Tuesday of next week. Leaf and branch collection will be finished before Memorial Day. Mr. Miller thanked the Road Department employees for cleaning up the ballfields and removing the dugouts which eliminated the safety hazard. Mr. Miller discussed the vandalism in the park and the need for cameras and additional patrols.

Mr. Miller discussed a parking situation at the plaza that our zoning officer is addressing. He also discussed a trailer on Catawba Avenue.

Mr. Miller address the Columbia Avenue project contracts.

Solicitor's Report-Mr. Rybeck advised the Columbia Avenue contracts

should be ready tomorrow.

Engineer's Report-

Mr. Johnson discussed Well# 5 Media SCRAPE and noted that well#5 will be offline for scheduled RAD maintenance in coordination with water personnel the week of June 7, 2021, 2-3 days. The materials will be disposed of by WRT with no on-site storage of materials.

The Stormwater Pollution Prevention plan must be updated, required by Tier A MS4 NJPDES permit. Mr. Miller asked that Borough Engineer, Wayne Johnson, be responsible for MS4 permit reports. Council will consider.

Mr. Johnson asked for authority to complete the Stormwater Pollution Prevention Plan, which was last completed in 2018. It is required by NJDEP as part of Annual report and red flagged in a report indicating an update is required. SPPP must also be posted on the Borough's web site once revised and updated. NJDEP considers SPPP a dynamic living document that never ends. Council gave no direction at this time. Council Pierce asked if SPPP is different than on the web site, Mr. Johnson informed Council that this was part of SPPP and that a book / binder of all documents must be kept on site in the Public Works Supervisor's Office for daily records and for a NJDEP audit.

Columbia Avenue reconstruction: Contracts must be completed and be signed to move forward, schedule preconstruction meeting and follow NJDOT requirements. The water services are all completed on Columbia, and the last service was done on April 23, 2021.

Nottingham basin mounded groundwater, field meeting on April 28, 2021 to try to get the developer to take action.

Council Miller requested that contracts be completed since Asphalt price numbers are rising.

Mrs. Angelo addressed a program that Franklin Township have on their Police website about autism. They created a registry for individuals with Autism in an effort to give police a quick access in an emergency to critical information bout a person who is registered. The registry can provide police with emergency contact information, detailed physical descriptions, known routines, favorite attractions and other helpful information for an individual with autism or other disabilities such as Alzheimer's, dementia, Down syndrome, or any other endangered individuals. This information can greatly assist police officers when time is essential in communicating and dealing with an emergency situation involving a person with autism as well as other disabilities. Mrs. Pierce agreed to look into the matter to get the information on the Borough's website.
