Regular Meeting July 14,2022 7:30 PM

Mayor Sullivan called the Meeting to order with a flag salute. This meeting was duly advertised in accordance with the Open Public Meetings Law, PL 1975, Chapter 231. Roll Call: Mayor Sullivan, Mr. Carrow, Mr. Miller, Mr. Corwonski, Mrs. Pierce, Mr. Linton and Mr. Grova. Absent: none. Also present was Solicitor Rybeck.

Paul Miola from the Atlantic County Joint Insurance Fund gave a presentation to Council about the Borough's Insurance. Nick Cashan was also present. Newfield was one of the JIF's founding members.

Committee Reports

Public Safety Chair-Mr. Grova advised that the police report was distributed to council. National Night Out will be held on August 4, 2022 at 6:30 pm at the Franklin Township Little League Complex.

Finance Chair- Mr. Carrow advised that the Tax Collector request Resolution #55-22 be added to the agenda this evening which extends the grace period for the third quarter taxes.

Grants/Economic Development/ Communication and Information Technology Chair-Mrs. Pierce reported that the 2023 Rabies Clinic has been scheduled for March 23, 2023 from 10:00am till noon at the Senior Center. The county will distribute the Rabies vaccine through the State.

Water- Mr. Corwonski reported that work is being done on the water tower.

Mr. Nicholson advised that the water meter reading equipment has been ordered and a purchase order has been sent to the vendor. The Borough will begin purchasing 50 meters and by the end of this year we will have 100 meters in place. The reader will be able to read meters while driving the trash truck.

Mr. Nicholson reported that the flushing is done and water quality is improved because the pipes are cleaner. They system will be flushed two times a year.

Mr. Linton asked about the painting of the hydrant's different colors. Mr. Nicholson advised that the different colors represent the pressure and flow of each hydrant which helps the Fire Department when fighting fires.

License & Inspection/Health& Welfare – Mr. Linton reported that 13 permits were issued for the month of June totaling \$1887. Properties are being cleaned and maintained. The zoning officer is following up on properties where violations have been issued. Currently, there is an issue with cars on a property that is working on.

Recycling and Trash/ Buildings, Grounds, Roads Chair- Mr. Miller discussed the vandalism at the library and discussed placing a camera in the rear of the library and increasing police patrols in the area. Parents are responsible for their children. The Park area is another problem area for vandalism

Mr. Miller advised that the recycling facility will be open August 6 and October 6. A shred even will be also held on October 6.

Solicitor's Report- no report.

Engineer's Report- Mr. Johnson advised he is working on the capital improvement report and submitted the Sandy Drive Municipal Aid Resolution to the State.

Mr. Johnson advised that he submitted the last piece of information to DOT regarding Columbia Avenue to close the matter.

He noted that there was a SJ Gas emergency repair at 205 Rena Street.
