**Call of the Roll: Mayor Sullivan, Mr. Carrow, Mr. Miller, Mr. Corwonski, Mrs. Pierce, Mr. Linton, and Mr. Grova, via cell phone.**

**Public Participation**

**Mr. Carrow made a motion to open the meeting to the public and Mr. Corwonski seconded the motion. All in Favor. No one in the public addressed the council. Mr. Carrow made a motion to close the public portion of the meeting and Mr. Corwonski seconded the motion. All in Favor.**

**New Business**

**Resolution #71A -22 RESOLUTION AUTHORIZING THE EMERGENT APPOINTMENT AND EXECUTION OF A PROFESSIONAL SERVICES CONTRACT WITH WADE, LONG, WOOD & LONG, L.L.C. (JOHN A. MOUSTAKAS, ESQUIRE) AS INTERIM MUNICIPAL ATTORNEY**

**Mr. Grova made a motion to appoint John Moustakas as interim Municipal Attorney. Mrs. Pierce seconded the motion.** John Moustakas provided some background on himself. Solicitor Moustakas worked for Wade, Long, Wood & Long LLC since April 2016 and prior to that he worked for the law office of Brian Duffield and clerked for Judge McMaster from 2002 to 2003. Mr. Moustakas advised that he has worked for several school districts and municipalities with a focus on municipal government and code enforcement. **Roll Call Vote: Unanimous. Motion Carried.** Mayor Sullivan administered the oath of office.

Mr. Linton advised that we are going to focus on rentals in the new year and add to the list of registrations in the Borough. The Zoning Official is going to perform inspections. Mr. Linton advised that the ordinance will be reviewed and amendments will be recommended to the council. Mr. Moustakas advised he could aid since he has experience with rentals in Gloucester City.

**Resolution # 72-22 RESOLUTION OF THE MAYOR AND COUNCIL OF THE BOROUGH AUTHORIZING THE EXECUTION OF A SHARED SERVICES AGREEMENT WITH THE TOWNSHIP OF MANTUA FOR THE MAINTENANCE OF VEHICLES AND SMALL ENGINES**
