Committee Reports

Public Safety Chair- As Chair, Mrs. Pierce provided the police report to all of council. There will be a Pop-Up event where the Police Officers rent a truck to give out ice cream in different neighborhoods. Mrs. Pierce congratulated officer of the month Anthony Colofranson for his hard work and dedication to the job.

Finance Chair-As Chair, Mr. Carrow reported that the budget has been finalized and will be introduced in May.

Grants/Economic Development/ Communication and Information Technology Chair- As Chair, Mrs. Marandino reported that:

- The special events committee has discussed the Newfield Day parade route, which may include the traditional route this year. The county stage rental is not going to be available this year,
- The pickle ball clinic will be an informal clinic.
- Easter egg hunt was very successful and the Bunny Burn Fitness event was also a success and the profit was \$320.
- Town wide yard sale is scheduled for May 20
- Movies in the park is scheduled for Friday June 16 at dusk.
- The Special Events Committee is in discussions with the Fire Chief about renting the senior center and splitting the profits.
- Mrs. Marandino noted two new members are listed on the agenda for appointment to the special events committee.

Water- As Chair, Mr. Corwonski advised that the shade tree would like to purchase planters and trees for the downtown district. Mrs. Marandino suggested contacting Huffman's for fund raising ideas.

License & Inspection/Health & Welfare – As Chair, Mr. Linton advised that 78 permits were issued for the month of March which totaled \$35,065. Mr.

Farabella has been dealing with a trash issue on Greenwood Avenue. The Construction official sent out a violation notice to 7 Salem Avenue for a roof reconstruction.

Recycling and Trash/ Buildings, Grounds, Roads Chair- As Chair,Mr. Miller reported that a shred event is being held tomorrow from 9-12:00 noon at the recycling facility. The Recycling facility will also be open to receive bulk items on May 6 from 8 AM until 12:00 noon. The last day for limb and leaf curb collection will be May 7. Mr. Miller suggested that our code official send out a warning to our first-time offenders.

Engineer's Report- Mr. Johnson reported that the water service laterals for Rena and Franklin were advertised for bid. A pre bid meeting will be held on April 27, 2023.

Mr. Johnson reported that he is busy with the storm water permits which are due May 1. The capital improvements permit is extensive and Mr. Marandino is working on a new component, which includes a leaf permit for the compost facility.

The resolution for the flood insurance is on the agenda. Once this is adopted, Mr. Johnson noted that he would send it to the state for further instructions.

Mr. Miller asked if there were any grant monies available for Sandy Drive. Mr. Johnson advised that we could apply for a second round of grant funds for Sandy Drive. The NJDOT did not fully fund the road reconstruction. A second round of funds could cover the full reconstruction and give the Borough a financial break from having to do water services on another project. The Water main job on Sandy is a big job and quite costly. There is a four-inch water main that was constructed in the 1950's. Mr. Nicholson, Licensed Water Operator suggested that we charge a cost-of-living increase every year for water and not wait to do an increase when funds are a concern. Mr. Miller asked if there were any grants available for water for this purpose. Mrs. Marandino advised there were no grants available at this time.

Mrs. Pierce made a motion to adjourn the meeting and Mr. Linton seconded the motion. AIF. The meeting was adjourned at $8:12\ PM$.
