Regular Meeting September 14, 2023 7:30 PM

Mayor Grova called the meeting to order with a flag salute. This meeting was duly advertised in accordance with the Open Public Meetings Law, PL 1975, Chapter 231.

Call of the Roll:

Members Present: Mayor Grova, Mr. Carrow, Mr. Miller, Mr. Linton and Mrs. Marandino and Miss Renzi. Absent: Mr. Corwonski. Also present was Solicitor, John Moustakas and Engineer, Wayne Johnson.

Committee Reports

Public Safety Chair- Mrs. Renzi reported the police statistics for the month of August.

Finance Chair- Mr. Carrow had no report.

Grants/Economic Development/ Communication and Information Technology Chair-Mrs. Marandino reported that:

- Triad Associates contacted Mrs. White about grant writing services for the Shade Tree Commission. Mayor Grova was invited to attend the next meeting. Mrs. Marandino advised that possibly Triad Associates can be invited to the meeting to give a presentation.
- Mrs. Marandino advised council if there is a need for one call messages to contact her.
- Mrs. Marandino asked council to sell chicken barbeque tickets for Newfield Day and noted that the parade begins at noon.
- Clean up day is October 1 and set up is October 6 and they are looking for volunteers. Anyone interested in purchasing mums from Huffman's, can do so by October 31.

Mr. Corwonski arrives at 7:40 pm,

Water- Mr. Corwonski reported that the planters have been placed around town and they will be filled with potted plants before Newfield Day. A tree was planted near the clock to replace a tree that had died. The Shade Tree Commission also performed some general maintenance in the park. Mr. Corwonski asked public works to help with the watering of the trees that are being planted. Mr. Miller agreed.

License & Inspection/Health & Welfare – Mr. Linton reported that 16 permits have been issued for a total of \$1,743.

Recycling and Trash/ Buildings, Grounds, Roads Chair- Mr. Miller had no report.

Solicitor's Report - Solicitor Moustakas advised he is looking into a shared service program for the Borough's vacant properties. The Solicitor advised he would discuss one other item in executive session.

Engineer's Report- Mr. Johnson reported that Crest Construction finished the water services. The project resulted in a substantial savings to the Borough since several services were found to be copper or poly and not in need of replacement with a savings of \$27,480.00.

Mr. Baumgart will provide an easement to the Borough on Franklin Street in exchange for a water service and additional access to his property from Franklin Street via the cull de sac. The water service can be extended from the Stotesbury Avenue interconnection easement and did not require immediate installation.

Mr. Johnson advised that a notice to proceed was given to South State for Rena Street reconstruction. Leeching pits will be installed at the curve on Rena Street as part of the grant and will not have to be installed by the public works employees as originally planned. Mr. Johnson explained that extending into the intersection is not feasible at this time due to the NJDOT requirements for drawing submission, review and approval. This could require that the contractor South State not be able to complete the additional intersection paving while the crews are on site and require a remobilization. During the design and approval process, construction prices were rising and the project was scaled back to ensure that the Borough would not have to expend funds for contract bids over and above the grant award. Since that time prices had stabilized and now the asphalt price index has started to rise again. Mrs. Marandino noted that a change order could be added.

Public Participation Mr. Corwonski made a motion to open the meeting to the public. Mr. Miller seconded the motion. All in favor. No one in the public addressed council. Mr. Miller made a motion to close the public portion and Mr. Carrow seconded the motion. All in favor. Motion carried
