Committee Reports

Public Safety Chair-Miss Renzi provided fire report to council.

Grants/Economic Development/ Communication and Information Technology Chair-Mrs. Marandino reported that she is working on the renewal of the one call system. There are 1200 contacts and the assessors provided a list that shows there are 634 homes. The list needs to be reviewed for duplicates and contacts that live out of town that should not be on the list. Mrs. Marandino asked for council's assistance to review the list. Council Marandino advised that she contacted the one call administrative office to determine if a meeting could be scheduled to address some questions. Mrs. Marandino reported that she will be meeting with Mr. Coffee in the near future regarding the website updates and he will update the pictures of the new council personnel. Mayor Grova suggested a link be included concerning Gloucester County weekly updates. Mrs. Marandino agreed to discuss with Mr. Coffee.

Mrs. Marandino noted that the special events committee needed approval for:

Our contract expires with the Fund in 2025. Egg Harbor City and Corbin City withdrew from the Atlantic County Joint Insurance Fund.

Engineer's Report-Mr. Johnson reported that WRT is assisting with the Radiative material renewal license. The safety procedures have to be kept on file in the well houses.
