Mr. Miller reported that he received a price for the roof on the old pump house located adjacent to Borough hall, but is now looking into pricing for a hip roof.

Mayor Grova reported that movies in the park was a great success.

Mayor Grova asked that an insurance presentation be scheduled for the next meeting for council to consider some options.

Mr. Nicholson reported there are continuing issues with WRT and alternatives need to be considered. Mr Johnson reported that he has a meeting scheduled for the Shieldalloy solar field project. He wants to discuss several issues which include the preservation of the front buffer along the Boulevard and requesting a benefit for the Borough of Newfield as a community solar array. The Community solar array would allow for reduced rate electric for the Borough residents. He also advised he will discuss the cleanup status EPA statement was in the report and ask Shieldalloy to provide an update at the meeting. Also, PJM status was discussed: Pennsylvania, New Jersey, Maryland Electrical Grid agreement for the proposed solar array.

Mrs. Engle advised she was presented with a question from a resident about a property on Catawba Avenue that appear to have several vehicles in their yard as to appear that they are running a business. It may create a hazardous situation if a fire occurred and fire vehicles had to gain access to the property. Council agreed to look into the matter.
