Regular Meeting July 10, 2025 7:00PM

Mayor Grova called the meeting to order with a flag salute. This meeting was duly advertised in accordance with the Open Public Meetings Law, PL 1975, Chapter 251.

Call the Roll: Mayor Grova, Mr. Carrow, and Miss Renzi, Mrs. Engle and Mr. Miller. Absent: Mr. Corwonski and Mrs. Engle. Also present was Solicitor Moustakas and Wayne Johnson, Engineer.

Committee Reports:

Public Safety Chair- Mayor Grova provided council with the police and fire statistics for the month of June.

Finance Chair- Mr. Carrow reported that the VFW purchased 115 flag holders for the veterans' graves. And Michael Magliocco, VFW member, assisted with the Memorial Day Service. Mr. Carrow advised he would like to have a proclamation prepared to honor the VFW. Council agreed.

Mr. Carrow discussed the memorial monument and noted that there will be room for 24 additional names.

Grants/Economic Development- Mrs. Engle announced that Movies in the Park will be held July 25.

Communication and Information Technology Chair- Miss Renzi noted that all of the dates for the Special Events Committee are listed on the agenda.

Miss Renzi advised that she would like a back up for the one call. There was an issue where the Mayor and Miss Renzi were not available when an emergency occurred in the Borough. Mr. Carrow's suggestion was for the Clerk and Deputy to learn the system. There have been a lot of one calls recently. Miss Renzi advised that she will do a follow up call regarding the water meters. A message will be placed on the water bills along with a second water one call.

Mayor Grova asked if the one call helped with the dog licenses. The clerk advised that the one call message did not generate any further dog licenses and that we need someone to go door to door.

License & Inspection/Health & Welfare – Mr. Miller reported that 9 permits were issued for the month of June which totaled \$2144.

Solicitor's Report – Mr. Moustakas advised that he sent a letter to the former owner of 2 North West Boulevard to remove all personal property inside the property within 30 of receipt of the letter. Engineer's Report-

Engineer's Report- Mr. Johnson reported there a is meeting with NJ Future Water.

The Rena Street project is being closed out and waiting on NJDOT approval of the revised final change order. The Franklin Street Reconstruction Project is completed and final payment is on agenda for meeting. The amended change order was submitted to NJDOT. There is a DOT resolution on the agenda for Woodlawn Avenue. Once that is adopted, it will be sent to the state for processing. The Sandy Drive drawings were submitted to NJDOT to allow bid award for October 31, 2025 in line with MA 2024 Sandy Drive deadline and to complete necessary water service replacement on Sandy Drive. Mr. Johnson advised that the borough can obtain free design assistance on water utility planning and development from the NJDEP for Well #5. Mr. Johnson advised that this is a long term solution with the replacement of well #5 media with a new design possibly using green sand plus. This will also include the cost of setting up the I Bank services.

Mr. Johnson advised council that he sent an email to Franklin Township engineer regarding the "no passing zone" on Weymouth Road and waiting to hear back from them.
