**RESOLUTION AUTHORIZING THE ADVERTISEMENT FOR THE SALE OF CERTAIN  
LANDS, OWNED BY THE BOROUGH OF NEWFIELD, NO LONGER NEEDED FOR A  
PUBLIC PURPOSE, IN ACCORDANCE WITH THE REQUIREMENTS OF
