

Regular Meeting Minutes
June 11, 2026

Mayor Grova called the meeting to order with a flag salute. This meeting was duly advertised in accordance with the Open Public meetings Law, PL 1975, Chapter 231.

Mr. Johnson advised that we have received notification from the DOT that the program is underway for 2027 and it is time to select a roadway that needs reconstruction. Mr. Johnson suggested choosing a roadway that would supplement the roads that have already been repaved.

Mr. Nicholson noted that the bridge work on Rosemont has been awarded to a contractor to repair the bridge. Council discussed this matter and determined that we are not responsible for the maintenance or refurbishing of the bridge.

The Conrail work on the crowing was postponed due to n emergency. Mr. Carrow advised that he would contact them tomorrow.

Miss Renzi reported that Mr. Carow suggested scheduling monthly bands in the park along with food trucks and refreshments. Miss Renzi advised that she would pay for the certificate of insurance and Mr. Carrow would help pay the band members along with donations.

Miss Renzi advised that the SJ Misfits are having a Kickball fundraiser event on June 27th.

New landscaping was discussed around the stage and possibly removing some of the bleachers that are severely damaged. It was suggested that a JIF official inspect the bleachers before any decision to demolish or repair them is made. Council agreed.

Mr. Curcio made moiton to adjourn the meeting and mts. Engle seconded the moiton. Meeting was adjourned at 6:57 PM.
