

RESOLUTION NO. 70-26
APPROVAL TO SUBMIT LAAEX-1 AWARD EXTENSION APPLICATION
ON EXECUTED GRANT CONTRACT WITH THE NEW JERSEY
DEPARTMENT OF TRANSPORTATION FOR THE PROJECT ENTITLED,
“DALTON AVENUE AND STOTESBURY AVENUE
ROADWAY RECONSTRUCTION PROJECT”

WHEREAS, the New Jersey Department of Transportation has awarded \$159,026 to the Borough of Newfield through the Municipal Aid Fund - FY 2025 for the purpose of reconstructing Dalton Avenue extending from the intersection of Madison Avenue County Route 661 to the intersection of Hazel Avenue and Stotesbury Avenue extending from the intersection of Madison Avenue County Route 661 to the intersection of Wood Street; and

WHEREAS, in accordance with the terms of the FY2025 Agreement between the New Jersey Department of Transportation and the Borough of Newfield, a contract for the project is to be awarded by November 13, 2026; and

WHEREAS, the Borough of Newfield will provide periodic progress reports to the New Jersey Department of Transportation as necessary to justify the need for an award of contract extension. The Borough Engineer recommends and respectfully request a 6-month time extension to this important project in the Borough due to the complications related to the water utility, water main and water service utility replacement work to be completed in advance of the MA-2025 Dalton Avenue and Stotesbury Avenue improvements to preserve the integrity of the reconstructed roadway and protect the significant NJDOT Municipal Aid grant investment in the area.

WHEREAS, a LAAEX-1 Grant Award Extension Agreement between the Borough of Newfield and the New Jersey Department of Transportation is required in order to procure said funds; and

NOW, THEREFORE, BE IT RESOLVED BY THE COUNCIL OF THE BOROUGH OF NEWFIELD:

- I. That the Mayor and Council hereby request that the Local Aid Fund - FY 2025 funds in the amount of \$159,026 to reconstruct Dalton Avenue extending from the intersection of Madison Avenue County Route 661 to the intersection of Hazel Avenue and Stotesbury Avenue extending from the intersection of Madison Avenue County Route 661 to the intersection of Wood Street be extended six months to May 13, 2027, to accommodate award of contract.
2. That the Borough will, upon being granted an award of contract extension and receipt of funds, complete the project in accordance with the Agreement approved and accepted by the New Jersey Department of Transportation.

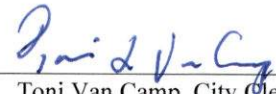
